Attention is invited to Notification No.67/2018-Central Tax dated 31.12.2018, issued by the Central Board of Indirect Taxes thereby amending the last date for completing the procedure of migration specified vide Notification No.31/2018-Central Tax dated 06.08.2018. Vide Trade Notice No.22/2018 dated 23.08.2018, this office had specified the detailed procedure to be followed and at para 5 specified the action and the time-lines to be followed by the taxpayers and the nodal officers concerned.
